Conditions of Entry to the Show

1. The Owners and Drivers of the vehicle /exhibit MUST be covered by a current Third Party Insurance Policy, including exhibitor use. A copy of which must be made available for inspection by the Fayre Organisers if requested.
2. Owners must ensure drivers are fully competent and have a valid and appropriate licence and be qualified in law to drive or handle the exhibit or entry.
3. NO vehicle / exhibit may be left running unattended and if unattended MUST be left securely 'braked and immobilized' with ignition keys removed where appropriate.
4. All Working vehicles / exhibits must be in a safe working condition and if to be driven to/from the Fayre Site MUST be in roadworthy condition with current insurance and MOT where appropriate.
5. Exhibitor support vehicles / trailers shall only be parked on the Fayre site for loading and unloading purposes prior to the hours of 12 pm (noon) and after 4.00 pm. All support vehicles / trailers must be parked in the main visitor parking area.
6. Please note that due to Health & Safety regulations, you may NOT move your exhibiting vehicle or exit the designated display area prior to 4.00pm. In exceptional circumstances or to participate in the 'cavalcade of vehicles' a vehicle may be moved if under the control of Fayre Organisers/marshals.
7. The MAXIMUM speed of 5 MPH shall apply to all moving vehicles on the site or access/egress routes to the highway. Any exhibitor found to be exceeding the speed limit will be asked to leave forthwith.
8. All owners and drivers must obey Fayre Organisers/Marshals instructions and not inconvenience or endanger any persons or animals on the site or on access/egress routes.
9. Owners are responsible for their own vehicle/s and personal effects/property and the Fayre Organizers accept no liability or responsibility in the event of any subsequent loss or damage.
10. All Individual Car Entries registered AFTER 1994 are only eligible at the discretion of the section organiser. (Not applicable to Car & Motorcycle Club entries). See separate entry form for club entries.
11. Entry is via vehicle pass only and any late entries will only be allowed at the discretion of the section organiser and subject to completion of an entry form on the day.
12. **Data protection.** Your name, address, telephone number, email and car details are being collected on behalf of the Plymtree Country Fayre & Horse Show. They will be used for the event's management and entry list. they will be stored securely and not be shared with other organisations and you have the right to withdraw your consent to use your data.
